- Vendors must remain set up until the event concludes at 3:30 p.m. Early tear-down is not permitted except in the event of an emergency or with Chamber approval.
- Booth assignments are determined by the Cut Bank Chamber of Commerce and may change based on event layout and operational needs.
- The Cut Bank Chamber of Commerce reserves the right to refuse or remove any vendor, display, product, or activity deemed unsafe, offensive, inappropriate, or inconsistent with the family-friendly nature of the event.
